We promote healthy lunches: Please consider the following:

- ✓ a morning snack, lunch, extra water in a safe container
- ✓ **Litter-less lunch containers** (refillable containers). Please Note: uneaten foods will be sent home so you know what your child has eaten on that day. WE ARE PROMOTING HEALTHY LUNCHES AS THE CHILDREN WILL LEARN ABOUT HEALTHY LIFESTYLES.
- ✓ **Peanut-free lunches**
- ✓ Avoid the type of food such as sweet drinks (especially apple juice) and sweet desserts as they tend to attract bees on hot days. Additional water supply and put in safe carry-about containers so your child has the option to have some on hand at all times. Send: **WATER IN SAFE CONTAINERS** (no bottled water please)

In order to safely open our summer day camps to the public, we have to abide by the rules and restrictions given to us from the Ministry of Public Health. We have had to make some changes to our programming.

Please note these rules and restrictions are subjected to change.

Q: How Will Camp be different this year?

A: Due to Covid-19 restrictions, horse-back riding will no longer be a part of our 2021 summer camp experience. There will also be a smaller number of campers (10), mandatory daily screenings, and all activities will be outdoors.

Q: Can I sign my child up for single days of camp?

A: Unfortunately, we are no longer offering single day sign ups for camp. In order to keep campers in the same cohort, all registrations must be for a minimum of one full week.

Q: Will all activities be outdoors?

A: Yes, all camp activities will be outdoors. Our farm has tons of beautiful green space where we can facilitate all camp activities! Our farm also is equipped with several outdoor sheltered areas (open barn, pavilion, trail shelter, and nature arena. We recently added a brand-new outdoor shelter to use as a space for activities.

Q: What COVID protocols are in place?

A: We are working hard here at the farm to enforce all COVID protocols given to us by the Ministry of Public Health. Some but not all of these include: enhanced cleaning, daily screenings for both campers/counselors/workers, hand sanitizer available at multiple spots throughout the farm, enforced social distancing procedures, and the following of mask mandates. All campers will also have their own bin with their own toys, writing tools, extra hand sanitizer.

Q: Will there be daily screenings?

A: Yes, both counselors and campers will be required to do daily COVID screenings. We please ask that you come prepared with your child's daily screening sheet filled out upon signing in (available on our website). If needed, we can provide you with printed daily screenings for the week.

Q: What about inclement weather?

A: Our day camps operate through rain or shine! If inclement weather does occur, please pack any appropriate items your child may need (i.e. raincoat, extra water, etc.). As mentioned before, we have covered outdoor spaces that are great for days with inclement weather.

Q: Will be child still have fun despite the changes and restrictions?

A: YES! We are very excited to be able to operate our summer day camps. We have so many fun and engaging activities to share with our campers this summer. We will still be doing daily interactions with our horses and baby chicks. Although this year may look a little different, the beautiful farm environment and excited horses remain the same!
